Data processing, purpose and legal basis

Data processors

Duration of processing

Your data will be deleted within five years of submission of the application.

We will only further process anonymised and aggregated data for statistical purposes. It will not be possible to identify you personally.

Withdrawal of consent

You may withdraw your consent at any time by sending an email to international@fh-joanneum.at. The data processed until such time and their use shall nonetheless remain lawful.

If you withdraw your consent all data will be erased and data processing will be stopped.

Other data subject rights

You have the following rights:

- the right to rectification (Art 16 GDPR) or erasure (Art 17 GDPR) or restriction of processing (Art
 18 GDPR) under the conditions specified in the relevant provisions;
- the right to data portability (Art 20 GDPR) if the related data processing is based on consent or contract performance and is carried out by automated means, as far as technically feasible;
