# Agreement

## on the provision and use of an electronic ID card for students

between

hereinafter referred to as the "Student".

### Preamble

The electronic ID card was introduced for students on all the Provider's degree programmes with effect from the start of the academic year in autumn 2000.

Alongside the typical functions of the previous student ID cards, the electronic ID card in credit card format is to perform additional functions (see Art. 3) and permit an efficient use of the facilities both for the Provider and for the students on the Provider's degree programmes, above all in terms of security and administration.

### Art. 1

#### Electronic ID card for students

The front of the electronic ID card for students in credit card format contains a photograph of the Student, his/her first and family name, date of birth, personal identifier and the validity period.

Each student is responsible for extending the validity of his/her ID card each semester. Printers are available on all campuses so that students can have the current validity date printed on the ID card, provided that they have paid the ÖH membership fee for the current semester and enrolled in the office of the respective degree programme.

### Art. 2

#### Obtaining the student ID card

Each student will receive his/her ID card (plastic card) in the office of the respective degree programme upon signing this Agreement at the start of their studies.

### Art. 3

#### Functions of the student ID card

The student ID card provides evidence that the student is enrolled as a regular student on one of the Provider's degree programmes. In addition, it also serves as a key (room access function for specific rooms of the degree programme or the building housing the degree programme) and as a copy card.

The ID card ceases to have the above functions once a student actually completes his or her programme (graduates) or withdraws from the course (drop-outs).

#### **Art. 4**

##### **Student's obligations**

The Student agrees, if requested, to send a photo in advance for the purpose of issuing an electronic student ID card. By sending the photo, the Student gives permission for the photo to be used for issuing an electronic student ID card. The Student also confirms that such use does not infringe any third-party rights in the photograph.

The Student undertakes to use the student ID card carefully and in accordance with its purpose, and to store it conscientiously. The Student expressly agrees to compensate the Provider for any damage incurred.

The Student shall use the student ID card in the manner specified in Art. 3 in strict compliance with the House Regulations, and shall carry it with him/her as evidence of his/her identity as a student of the Provider when on the Provider's premises.

In the interests of the security of all students and of the Provider's premises and infrastructure, the student ID card must not be lent or passed on to any other person, not even for a short period of time. The ID card must not be used to obtain access to the premises for accompanying persons.

If the ID card is lost, the Student shall immediately notify the office of the respective degree programme and keep proof of this notification.

#### **Art. 5**

##### **Infringement of the obligations**

In particular in the event of an infringement of Art. 4 and if damage results from the incorrect use of the student ID card, the Provider reserves the right to block the functions listed under Art. 3 immediately and until further notice – irrespective of any claims for damages arising for instance from an infringement of the obligations.

#### **Art. 6**

##### **Reissue of a student ID card**

If a new electronic student ID card is required, for example due to loss or damage, the Student shall apply for the issue of a new card to the office of the degree programme. The procedure described under Art. 2 shall then apply as a matter of principle. In addition, the amount of € 15.00 shall be payable to cover the production costs.

#### **Art. 7**

##### **Miscellaneous**

The Provider reserves the right to restrict the functions listed under Art. 3, in particular the room access function, for instance outside lecture times.

This Agreement shall be effective upon signature by the Student.
