Information for incoming students according to DSGVO

when completing a semester abroad in Austria

Introduction

Your application to complete a semester abroad in Austria supplements the legal relationship between you and your home university.

FH JOANNEUM Gesellschaft mbH as your target institution with a branch in an EU country is subject to the provisions of the GDPR. We may therefore inform you about the processing of your data as follows:

Data processing, transferee, purpose and legal basis

The processing of your data according to the application or table is carried out by employees of FH JOANNEUM Gesellschaft mbH, Alte Poststraße 149, 8020 Graz, based on and for the purpose of processing and fulfilling your application for a semester abroad in accordance with Article 6 paragraph 1 lit. b DSGVO.

The transmission of your personal data to the FHK as well as the transmission of the TOR and residence confirmations to your home university is exclusively based on your explicit consent according to Art 6 para 1 lit a DSGVO.

You can revoke this consent for the future at any time without giving reasons. You can submit the revocation at international@fh-joanneum.at.

Other data subject rights
