The part-time master degree programme forms the interface between IT, law and management. IT experts are increasingly confronted with questions of legal status in terms of contract law, software licences, data protection, online sales and e-commerce.

The programme offers students a comprehensive education in the fields of e-business, commercial law and IT law, data protection regulations, media and telecommunications law and IT project management.

The programme is designed to allow students to combine career and family: around 60% of the course is completed via e-learning, and students need only be present on campus on one weekend per month.
